Nominations for the 2018 General Assembly

Nominations and elections of our representatives to the various Committees, Agencies and Boards will be docketed for the November meeting of Presbytery. This summary will permit time for you to consider who you would like to nominate or if, in fact, you would like to serve the General Assembly in any of these capacities.

Nominations are due to the PCA Stated Clerk’s office no later than *FEB 13, 2018*.

(PCA Statistical Reports are due by Feb 15, 2018.)

A. Presbytery shall ELECT representatives to the following Committees:
