## **Nominations for the 2023 General Assembly**

Nominations and elections of our representatives to the various Committees, Agencies and Boards will be docketed for the **November meeting of Presbytery**. This summary will permit time for you to consider who you would like to nominate or if, in fact, you would like to serve the General Assembly in any of these capacities.

**(Annual Statistical Reports are due by **Feb 15, 2023**, with a copy to Presbytery.)**

**A. Elections for the Nominating Committee and RPR are due to the PCA Stated Clerk's office no later than **FEB 13, 2023**.**

**Presbytery shall ELECT representatives to the following Committees:**

1. One **Teaching Elder (or RE)** to the **Nominating** Committee (to serve 2024-2026)
2. One **Ruling Elder (or TE)** to **Review of Presbytery Records** Committee (to serve 2024-2026).

**B. Presbytery shall ELECT one Teaching and one Ruling Elder to the **Overtures Committee** (to serve only at 2023 GA). NOTE: it requires a 2/3 vote to approve anyone to serve more than two consecutive Assemblies. **(Due by Apr 14, 2023)****

**C. Presbytery shall ELECT representatives to the following Committees of Commissioners** (to serve only at the 2023 GA): **(Due by April 14, 2023)**

**I. The Nominating Committee meets on **March 25, 2023**, in Atlanta. (The meeting may be electronic depending on circumstances.) Those elected to serve on that committee should be available for that meeting.**

**J. The RPR will meet **May 31 - June 2, 2022**, prior to General Assembly. Those elected to serve on that committee should be available for that meeting.**
