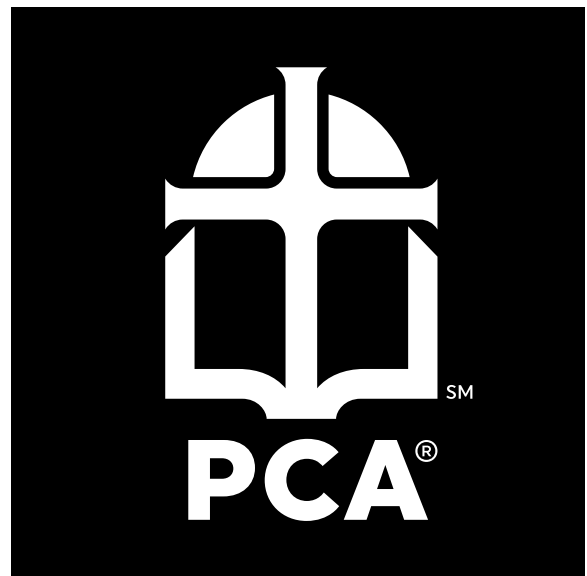

SPACING



To ensure visual clarity, allow for ample space around the landmark. This exclusion zone should be free from any other elements.

MINIMUM SIZE



MINIMUM WIDTH 0.375"

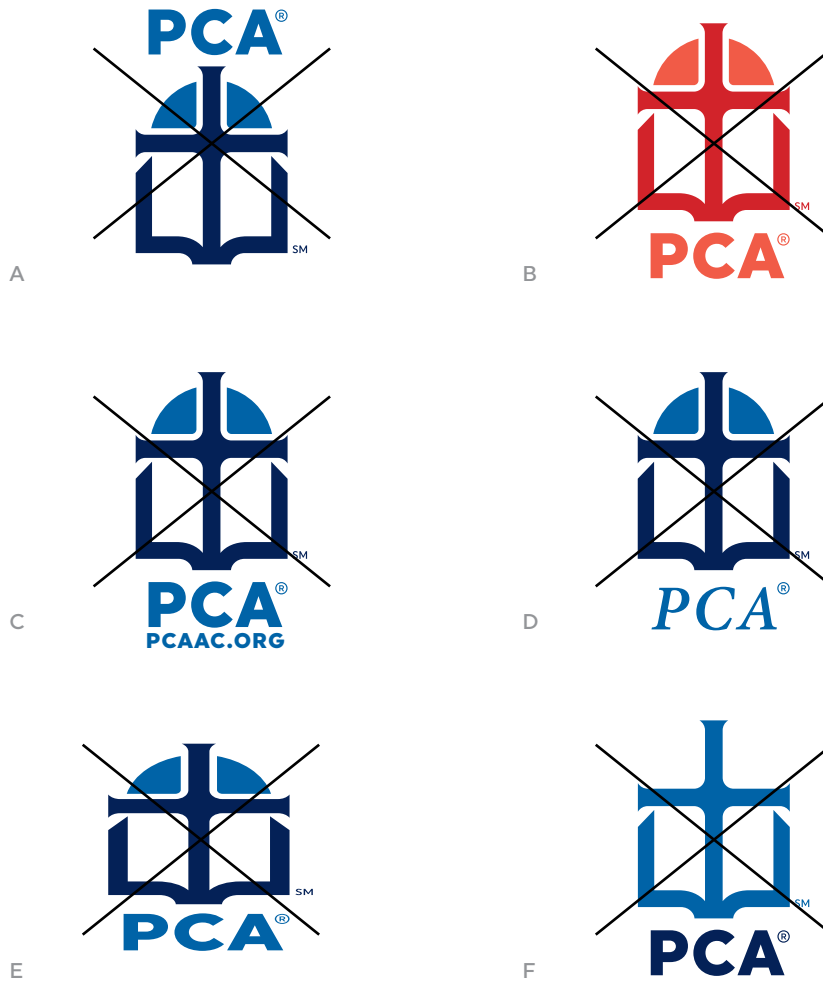


MINIMUM WIDTH 0.5"

To ensure legibility, adhere to the minimum reproduction size of each individual landmark layout.

MISUSE

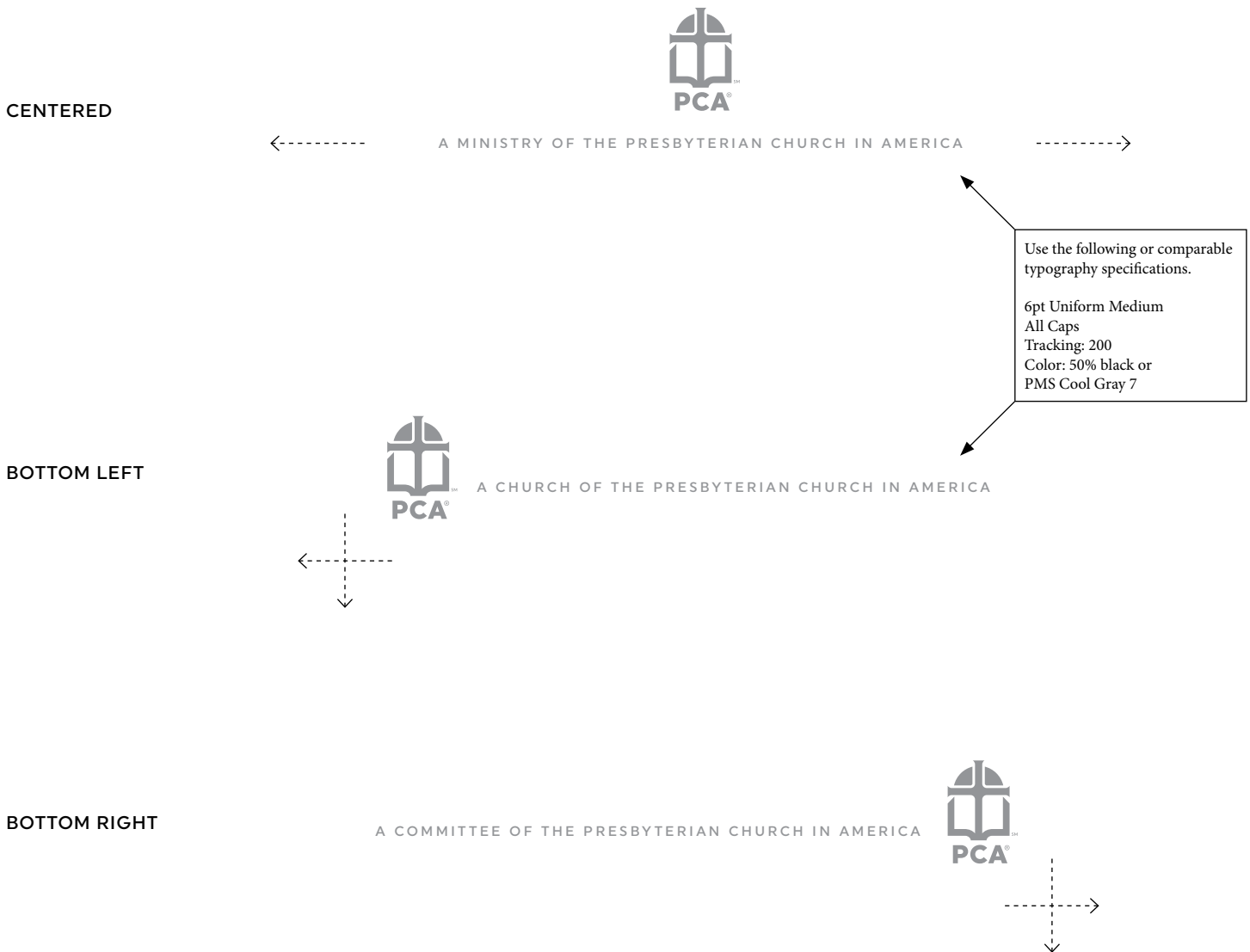


DO NOT:

- E. Stretch or condense
